Meeting Summary

1. Welcome & Introduction

1. Members signed in.
2. Welcome by the Chair of the Steering Committee [Doug Ambedian].
3. Introductions
 - a. Confirmed agenda
 - b. Only three (3) PAG members were in attendance. The Terms of Reference states: “Each decision requires a quorum of greater than 50 percent of PAG representatives or in their absence, their alternate.” There are currently nineteen (19) Sectors represented on the PAG so quorum for this meeting is 10.
4. Meeting evaluation results for March 28, 2007 meeting reviewed.
5. The review of the minutes of the March 28, 2007 meeting was tabled to the next meeting.

2. Operational Update – Canfor & BCTS

John Moreland (Woodlands Manager for Canfor Mackenzie) gave an update on Canfor’s operations in the Mackenzie TSA.

1. Cost structure: Various factors go into determining the costs of producing lumber (incl. Fuel consumption (approx 4.5 litres/m3), softwood lumber duty, etc.). Current lumber prices don’t even cover logging cost, let alone milling and delivery costs. The Canfor’s mill is currently loosing approx. \$192/thousand board feet of lumber. The expectation is that this issue will

remain for an additional 18 months therefore more shutdowns will occur as the industry realizes they cannot wait this one out without mill closures.

2. The supply of purchase wood is not coming up for sale fast enough to meet Woodland's expectations.
3. Strategies to reduce costs: Logging camps have shutdown, Contractors have been consolidated or reduced, staff have taken pay cuts and Contractors will be asked to take cuts.
4. The current Market Pricing System is negatively affecting stumpage costs. Dead, dry timber (Grade 3) is gone from the Appraisal system. Stumpage on Woodlots is lower so Canfor has purchased more Woodlot wood.
5. A Provincial Round Table is positive step for the long term. It won't help in the next 6 months.
6. At the end of the day, new technology will help with the bottom line and the wood supply in the TSA will remain very strong. Mackenzie will get through this. The challenge is to stay in the game.
7. Question: What is the difference between the BCTS stumpage and Licensee stumpage?
Answer: Licensee stumpage changes every quarter while BCTS stumpage changes monthly. At times, BCTS stumpage will be higher. The base stumpage is 30% lower than licensee stumpage and the market decides the final price for the wood. Many times, bidders will bid up the price. Negative bids are not allowed.
8. The Appraisal Manual now allows for a sliding Baseline to account for the variable cost of developing the Timber Sale.
9. The formula used to calculate stumpage has an initial number that is modified by allowances for operational variables associated with developing the block.
10. Question: How is haul distance determined? Answer: The nearest processing facility to where the timber is being harvested.
11. PAG members noted that the timber is there but access to timber will be an issue in the longer term as supplies dwindle in other parts of the province.
12. There is a Mid-Term Timber Supply Mitigation Strategy being developed and scenarios have been modelled. Currently, 44% of the Timber Harvesting Land Base is pine-leading. These scenarios don't show a mid-term Allowable Annual Cut impact rather the concern is over capturing the quality remaining in the recent beetle killed wood. Other pests and diseases are incorporated into the scenarios.
13. Once short term pine harvests decline, the mills will need to reconfigure to handle the bigger piece sizes in the spruce and balsam.
14. Question: What is the estimated "shelf-life" of the dead pine currently? Answer: 5 years.

Steve Knowles (BCTS) gave an update on BCTS operations in the Mackenzie TSA.

1. BCTS is an “arms-length” branch of the Forest Service. They are given an apportionment of the Mackenzie Allowable Annual Cut, just like the licensees. BCTS apportionment is currently 718,000 m³ conifer and 50,000 m³ deciduous in a partitioned cut.
2. There now is a local demand for Aspen chips.
3. There is an interest in bringing more volume on line in the program.
4. Currently at 900,000m³ and moving close to 1,000,000m³
5. With the pricing mandate, BCTS always needs to consider the value of the wood and keep the Timber Sales priced correctly.
6. There has been some undercut in the BCTS program over the years and this undercut may be available to increase the BCTS program in a given year.
7. Estimating 1,000,000 m³ next year.
8. Trying to keep a steady stream of wood on an annual basis.
9. Some birch is now being harvested with the deciduous harvest. This currently is an issue. Birch trees contribute to Waste and Residue on the block if the birch is not part of the block retention.
10. Due to the reduction in the number of sawmills, chip supply and sawdust supply has become an issue and the pulp mills need to source other suppliers of chips.
11. Question: What about accounting for deciduous volume in conifer leading stands, as this volume is not part of the deciduous partition? Answer: Deciduous volume is determined by whether the stand is deciduous or conifer leading. If a conifer – leading stand has a deciduous component, it is not contributing to the partitioned volume.
12. Concern from the PAG that not accounting for the coniferous volume in a deciduous stand and vice versa means that overcutting of deciduous may be occurring.
13. BCTS has a 5-year “Commitment Control” around rate of harvest which is similar to licensee 5-year Cut Control.
14. Historically, the deciduous volume has been undercut in the TSA.
15. PAG concern that the community doesn’t know where timber harvested by BCTS is going. Is it staying in the TSA or is it leaving?
16. Question: How does the public find out about operations in certain areas? Answer: Either visit the District Office or visit the BCTS website for summary information. Map products are available on request from the BCTS District Office.

3. SFM updates

Doug Ambedian and Tim Sproule described measures related to updating the SFM Plan :

1. Public Opinion Survey – completed and available to review. The results will be presented to the PAG at a future meeting. Mackenzie results will be compared to the rest of the province.
2. SFM Mapping – Indicator mapping is ongoing and will be completed this fiscal.
3. CWD Interim Targets – Baseline targets by Biogeoclimatic Zone (BEC) will be developed this fiscal.
4. Species Composition of Unmanaged stands – to be completed this fiscal.
5. Stakeholder Update – Database being updated this fiscal.
6. Non-timber benefits and effects of SFM – Project tendered in November however it was declined as not being FIA eligible. Will try again next fiscal.
7. Site Index by BEC – completed in December.
8. Productive Forest by BEC in Non – harvestable landbase – completed in February.
9. Peak Flow – some GIS work remains to be completed. Aiming for end of April. Once the Peak Flows have been calculated for each watershed there will be discussion with the PAG on where to go next with Peak Flows.
10. Strategies for LRMP-identified wildlife species – still working on strategies. Some overlap with Species at Risk. Still need to formalize these connections.
11. Canfor projects ongoing to align with potential revisions to the CSA SFM Standard:
 - a. Bird Inventories – monitoring of bird species and their associated habitats;
 - b. Ecosystem Representation – identifies relative percent of ecosystem groupings on the landscape, thereby identifying those that are rare and need special protection;
12. A series of projects are proposed for Fiscal 2008-2009 related to the CSA “Core Indicators”.
13. PAG members note that Peak Flows may become more extreme as the area returns to Winters with more snow and warmer Springs. How harvesting affects the timing of the snow melt will contribute to the Peak Flows. Will the criteria used to calculate Peak Flows keep up with what happens on the landscape? Climate Change is also a variable that is not well understood. Mountain Pine Beetle has killed large amounts of pine forest that traditionally retained moisture in the soil.

4. Plan for Moving Forward

How to best use the time spent with the PAG over the next year. Over the past year there have been staffing / resource turnovers within BCTS and Canfor.

1. Annual Report Presentation
 - (i) There is the expectation that the Annual Report will be produced for September of each year. This Annual Report gives the PAG the opportunity to evaluate progress toward SFM in

the Mackenzie TSA. The 2006-2007 Annual Report is now overdue. The objective is to have the report ready for the next meeting.

2. Refinement of SFM Plan

(i) Hoping to bring forward a few refinements to the SFM Plan related to monitoring and tracking the measures in the Plan. Proposed modifications to measures will be presented to the PAG. These modifications will provide for more efficient integration into current operational processes.

3. Proposed new CSA Standards

(i) CSA is now revising the SFM Certification standard. The Standard is revised every 5 years. The proposed revisions are in draft format and the public have been asked to review the draft Standard and provide comment. Deadline for public comment is April 7, 2008.

(ii) A key component of the revised standard is the incorporation of a suite of “Core Indicators” for each of the CSA SFM Elements. Some of the Core Indicators may be familiar and already a part of the Mackenzie SFM Plan. Once the new Standard gets established, any CSA SFM certification re-registrations will have to align with the new Standards.

(iii) PAG members reviewed the CSA SFM Elements and associated “Core Indicators”.

(iv) Canfor is developing a standard suite of indicators across all their divisions. This is required within Canfor in order to be more efficient with reporting processes. These indicators align with the draft “Core Indicators”.

(v) PAG members expressed concerns with the adoption of “Core Indicators” in that some of the local issues and measures may be lost or watered down.

(vi) There is no limit to how many indicators can be in the SFM Plan. The Core Indicators are meant to allow for consistent measurement at regional, provincial or national scales.

5. Review of Terms of Reference

1. The PAG members in attendance are comfortable with continuing to include the following element in the Terms of Reference:

(Section) 1.4 Public Advisory Group

The Public Advisory Group (PAG) for the Mackenzie SFMP is comprised of individuals representing the interests listed in section 6.1.1. who voluntarily participate in the PAG process. As outlined in the Terms of Reference, the PAG will specifically work under the Defined Goals (Section 2) as an open, transparent, and accountable process. The Mackenzie SFMP Steering Committee and the PAG recognize and agree that Aboriginal participation in the public participation process will not prejudice Aboriginal and Treaty rights.

2. The PAG discussed how Sector representatives are able to represent that Sector at the meeting. PAG members have a good understanding of the needs of their Sector and PAG

members are able to listen to and understand the perspectives of the other Sectors in order to reach consensus.

3. PAG members discussed the membership issue and reviewed the current PAG Representative and Alternate list. Some PAG representatives have not attended meetings in a long time. Canfor and BCTS acknowledged that this meeting was organized on short notice.

Action Item #1: LSC to review PAG attendance records and bring recommendations to next meeting.

6. Presentation and Review of Audit Results

1. Canfor presented their Assessment Findings from November 2007.

a. Canfor had zero (0) Major Non-conformances, three (3) Minor Non-conformances and ten (10) Opportunities for Improvement

vii. Signs / delineators on bridge approaches.

viii. Contractor possession of obsolete Slocan environmental instructions.

ix. One forwarder missing a Spill Kit.

x. Entrance of feller buncher into a ribboned Non-productive (NP) zone.

xi. Previously Open OFI: Discrepancy between the map and the ribbon location.

xii. Previously Open OFI: Block Risk Assessments

xiii. Previously Open OFI: Contractor awareness of Canfor Emergency Response Plan.

xiv. Previously Open OFI: Linkage between EMS responsibilities and SFM

 - i. Ongoing and meaningful public participation, progress towards or achievement of performance targets, and continual improvement in performance.
 - e. Minor Non-conformance related to:
 - i. EMS manual procedures for addressing the transportation of dangerous goods and for emergency preparedness and response.
 - f. Opportunities for Improvement related to:
 - i. Procedures and Audit Records

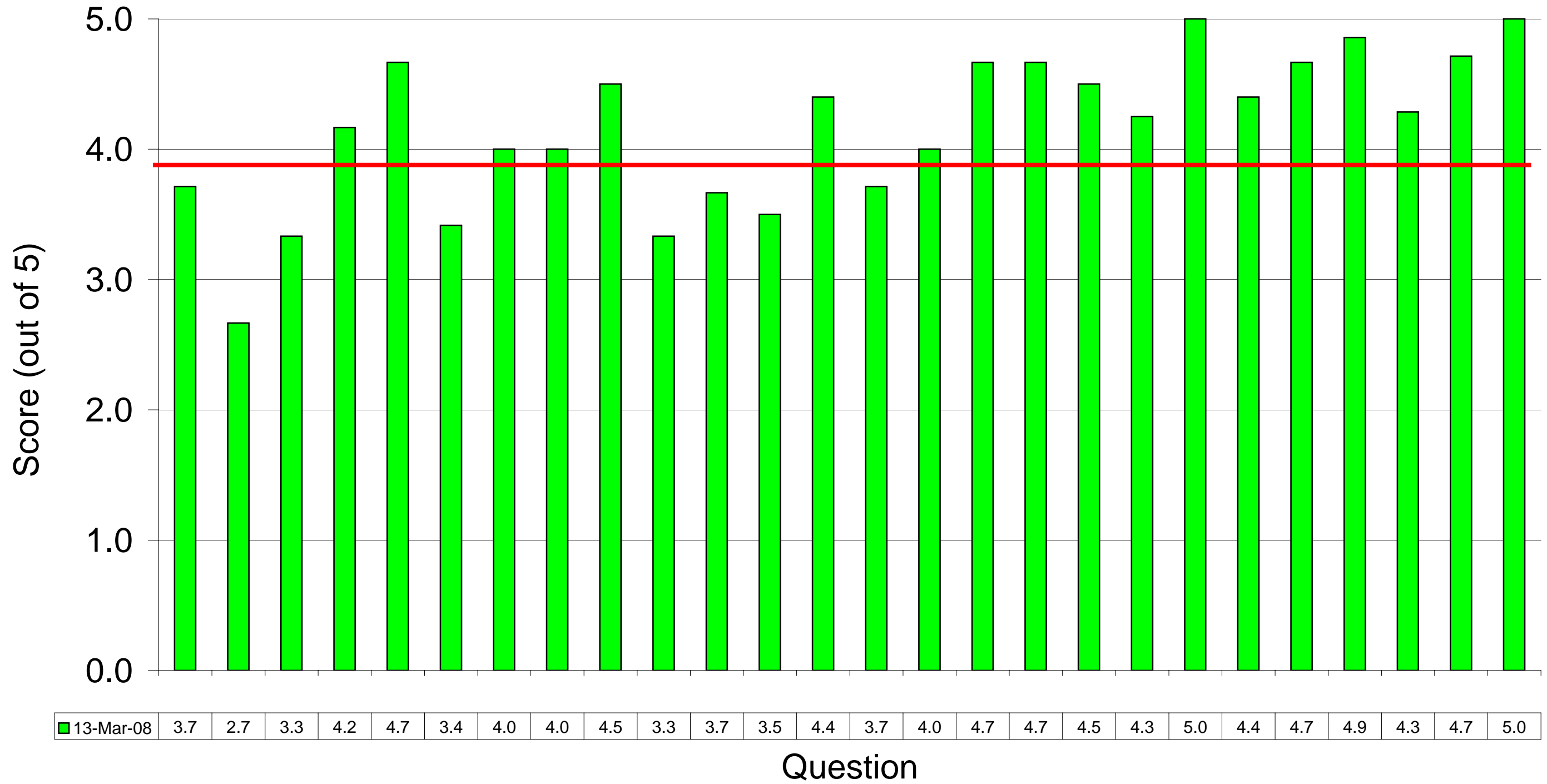
