To be valid, this form of proxy duly signed and any power of attorney or other authority under which it is signed must be sent to the Company's Transfer Agent, TSX Trust Company Inc., Proxy Department, P.O Box 721, Agincourt, ON M1S 0A1, or the Secretary of the Company, not less than 24 hours (excluding Saturdays and holidays) before the time of the Meeting.
